## TERMS OF WARRANTY

- 1. As the manufacturer PPH MAKOT hereby warrants the correct operation of this device under the following conditions of: (a) its proper installation and (b) operation in accordance with its intended use and operating instructions.
- 2. The warranty is granted within the territory of the European Economic Area countries and Switzerland.
- 3. The warranty period is 12 months from the date of purchase, however maximum 15 months from the date of its manufacture. If the manufacturer has made significant repairs to the device under the granted warranty, the warranty period runs again from the moment when the device is returned to the user. In other cases, the warranty period is extended by a period, during which the user could not use it due to a defect in the device.
- 4. Complaint should be submitted directly to the manufacturer of the device, by enclosing this warranty card.
- 5. The applicant shall bear the costs of disassembling the device and its delivery to the manufacturer for repair under the warranty. The costs of returning the device, related to an unjustified complaint, are borne by the applicant.
- Unauthorized repairs carried out by a third party, shall result in the loss of rights under this warranty.
- 7. Under the warranty hereby granted, the manufacturer undertakes to repair the device free of charge only if the defect of the device was caused by the fault of the manufacturer or due to hidden material defects.
- 8. **The warranty does not cover** damage to the device caused: (a) during its transportation, (b) its improper storage, (c) wrong installation, (d) incorrect maintenance, (e) misuse of the device or its operation against the user manual. **The warranty also does not apply to**: (f) mechanical, thermal or chemical damage of the device, (g) damage caused by the flooding of the device and (h) short-circuits or overloads of the control outputs, as well as (i) damage resulting from unauthorized repairs carried out by the user or a third party and (j) damage caused by running a parallel power supply and control line or other power cord together with a temperature sensor wire at a distance of less than 5 cm from each other.
- 9. The manufacturer cannot be held responsible for any material damage or injury resulting from any of the circumstances mentioned in item 7 above.
- 10. Based on the warranty granted the manufacturer will repair the device within 20 business days from the date of providing the device covered by the complaint.
- 11. The warranty granted hereby does not limit or suspend the rights of the buyer under the statutory warranty for defects in the sold goods in accordance with the laws of the Republic of Poland.

ATTENTION: Faulty operation of the device may result from its incorrect installation and/or configuration, as well as from unawareness of the operating instructions.
